7. If the last day for submission and opening falls on a government holiday then the next working day shall be considered as the last day.
8. Bid should comply in all respects with the Instructions to Bidder included in the Bid Document. Noncompliance with this instruction will result in disqualification.
9. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
10. Bidders may submit modification or withdrawal prior to the deadline prescribe for submission of bid through e-GP system by using the forms and instructions provided by the system. Once a Bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
